Show Categories and Prizes:

First Prize in each category will be \$56.00 in honor of PAFAC Anniversary of 56 Years. There will be a panel of 3 independent judges to make this decision. There will be a total of 6 categories:

1. Watercolor
2. Acrylic/Mixed Media and Oil Painting
3. Graphics (Pencil, Charcoal, Pastel, Pen & Ink, Computer Generated Art, Wood Burning)
4. Photography
5. 3D (Wood Carving/Wood Working, Sculpture, Jewelry)
6. Fiber Art (Quilting, Sewing, Needle Point, Rug Hooking)

There will be a people's choice award in the amount of \$50. This will be voted by the people who attend this show.

There will be a Best in Show prize of \$150 that will be decided by the panel of independent judges.

All Judges decisions will be final.

Rules:

The entry fee for 3 pieces of art will be \$20 if you are a PAFAC member and \$30 if you are not a PAFAC member. A PAFAC member is a current member who has paid their 2018 dues. If you would like to become a PAFAC member at this time, you may join by visiting our website parmafinearts.org or calling PAFAC at 440 888-4514.

You may enter all 3 pieces in the same category or enter 3 pieces in the appropriate categories. The limit is 3 pieces per entry fee.

1. PAFAC will be promoting this event in local newspapers and social media outlets.
2. PAFAC will only accept handmade items by the artist for this show.
3. Your pieces may be for sale and all artists are responsible for collecting and reporting Ohio sales tax. PAFAC will not be held responsible for any taxes from your sales. PAFAC is not responsible for any vendors license that may or may not be needed. That will be the responsibility of the vendor.
4. PAFAC, The Donna Smallwood Activity Center or the City of Parma will not be responsible for any damage claims, theft, damage to materials, displays, tangible or intangible property or physical injury from the use of the premises provided. This is solely the responsibility of the artists.
5. All framed and canvas art must be ready to hang with a wire.
6. All dimensional work can have stands or displays if they are 3D.
7. All Watercolors must be framed.
8. All artwork must be tagged with Artist name, category, size, medium and price or NFS. (Not or sale).
9. Any painting over 3' x 4' will not be accepted.
10. Judging will take place by our panel of independent judges on Friday evening at 7:00 pm.
11. All entries are to be received on Friday, May 18, 2018 between the hours of 4:00 to 6:30 pm at the Donna Smallwood Activity Center. Any entries received after 6:30 will not be judged.
12. Entries will remain at the Donna Smallwood Activity Center until the end of the show on Saturday.
13. You may pick up your artwork after the show on Saturday, May 19, 2018 between the hours of 4:00 pm and 6:00 pm.
14. PAFAC does not have the space to keep any artwork. If you are unable to pick up your artwork, please make other arrangements for retrieval of your artwork. Any artwork that is not picked up after 6:00 pm may become property of PAFAC.
15. All prize money and ribbons will be awarded the day of the show.
